Please also be reminded that the test is voluntary, although encouraged, and should your child not want to be tested they will be reassured that this is fine.

Test kits will be pre-registered for those students who have returned their consent forms. You may receive an email from a .gov email address about this. You do not need to contact the school about whether you have received one or not, testing will still be carried out for those students who have consent.

Students should continue to use their designated gates and arrive on time please. I am really looking forwards to welcoming all of our students back into school Monday!
